ARTICLES OF INCORPORATION
OF

FREDERICKSON CLOVER CREEK COMMUNITY COUNCIL

In compliance with the requirements of Laws of the State of Washington, RCW 24.03 and amendments thereto, the undersigned, all of whom are residents of the State of Washington, and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

ARTICLE I.

NAME

The name of the corporation shall be:

Frederickson Clover Creek Community Council

ARTICLE II.

TERM

The corporation shall have perpetual existence.

ARTICLE III.

PURPOSES

The purpose of the Frederickson Clover Creek Community Council shall be to seek to maintain and improve the quality of living in the community by providing a forum for the exchange of ideas among the members of the community, thereby giving an opportunity for the development of common interests of the residents and non resident property owners of the community.

In addition, the Council will be involved in continuing study in, but not limited to the following: land use planning and zoning; growth and development; community participation; environmental issues; roads and transportation; recreation; public services; business interests.

ARTICLE IV

The address of the initial registered office of the corporation is as follows:

ARTICLE V

The number of directors constituting the initial Board of Directors shall be 11, as follows:

The Executive Board shall consist of five elected officers, namely President, Vice President, Recording Secretary, Corresponding Secretary, and Treasurer to be elected from the community at large. In addition to the five officers named, there shall be one neighborhood representative from each of the six districts, to be elected by the membership. (see enclosed map of the six districts) The directors of the corporation shall hold office for one year and until newly elected officers are installed.

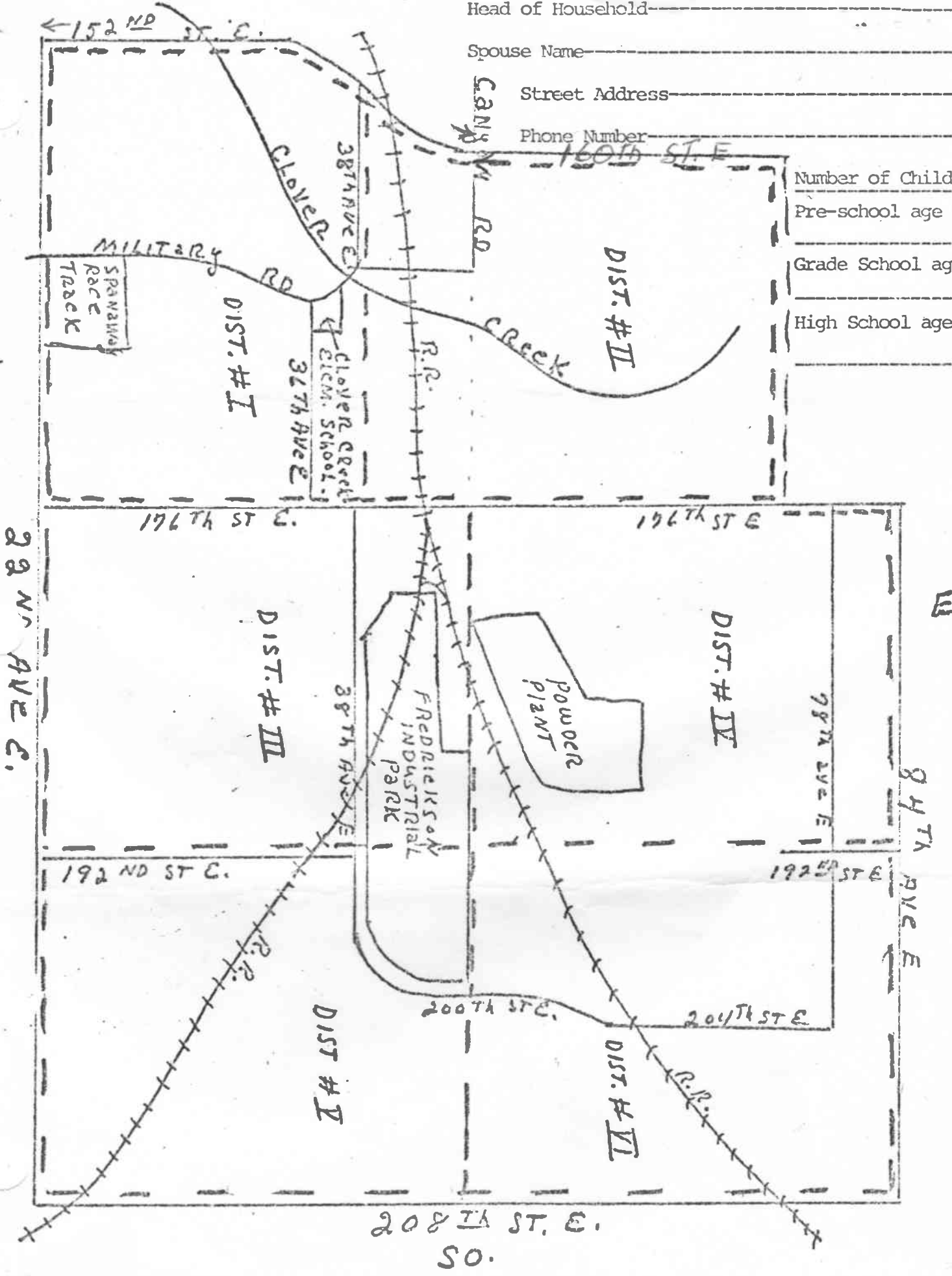
